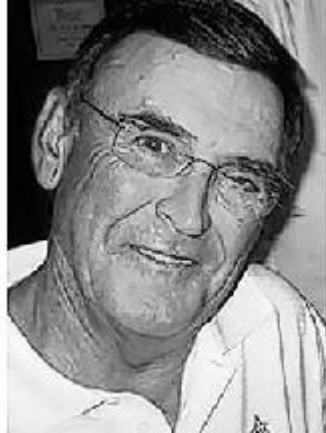
Saturday night dinners will be on your own with your students. Contact Jennie Stipick if you would like to join up with other host families for Saturday night.

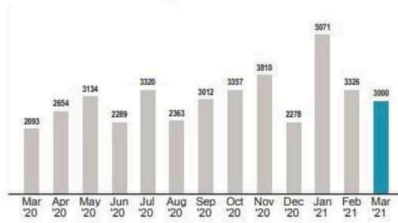
